

## STATE LEA FUNDING / LOANS AND BONDS ARKANSAS DEPARTMENT OF EDUCATION

### About the report:

As of June 30, 2016, Arkansas public school districts and education service cooperatives had outstanding loans and bonded indebtedness totaling \$4,278,937,210 -- an increase of \$188,005,994 over the previous year. Non-bonded debt with an energy savings contract is excluded from total indebtedness in calculating the debt ratio of school districts (Ark. Code Ann. § 6-20-405 (a)(1)(D)). Of the 235 Arkansas school districts that acquired debt in fiscal year 2015-2016, 2 districts had no debt; 49 districts had a debt ratio over 0% up to 5%; 87 districts had a debt ratio over 5% up to 10%; 51 districts had a debt ratio over 10% up to 15%; 35 districts had a debt ratio over 15% up to 20%; 11 school districts had a debt ratio over 20%.

Postdated warrants, lease purchase agreements, and installment contracts must be registered with the Department of Education and "shall be a part of the total debt of the district" (Ark. Code Ann. § 6-20-402 (b)(3)(A)).

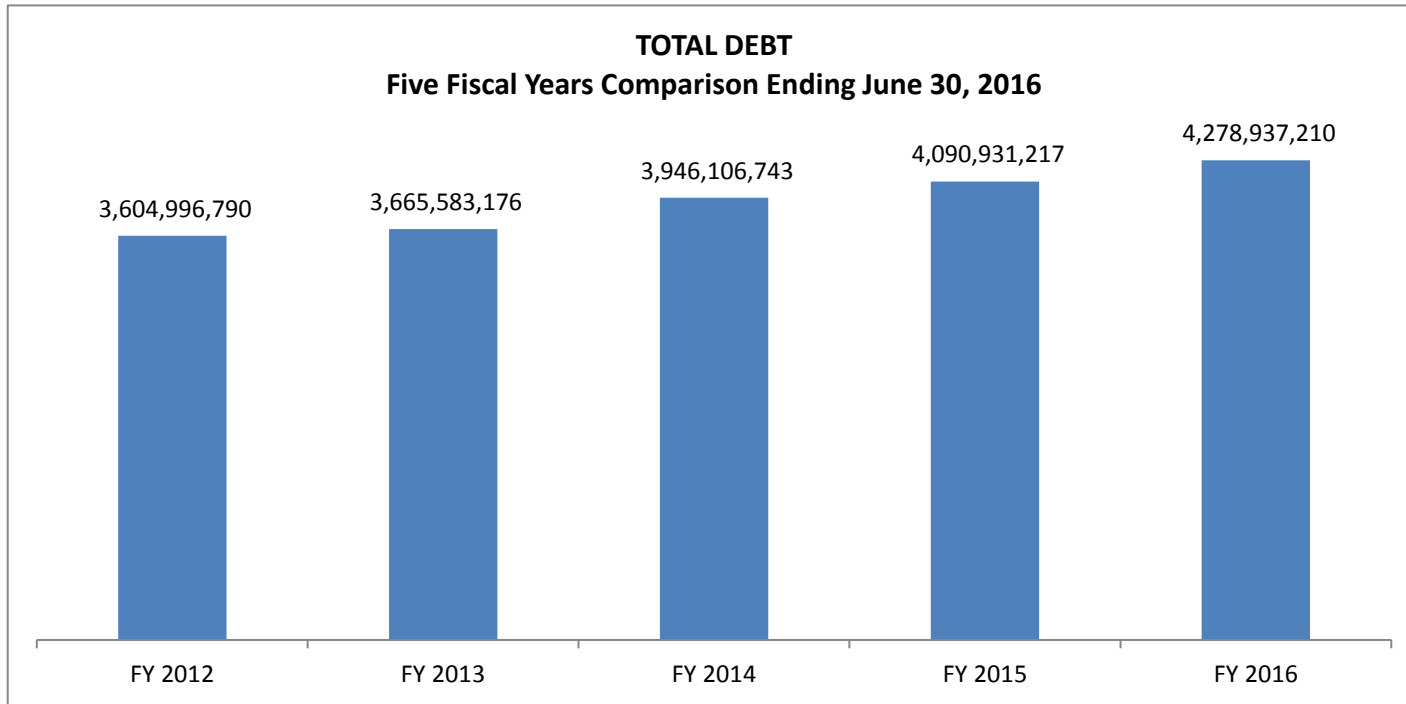
The calendar year 2015 statewide average millage rate for school districts in Arkansas was 37.74 mills.

That total state assessed value reported is as of the date of this publication.

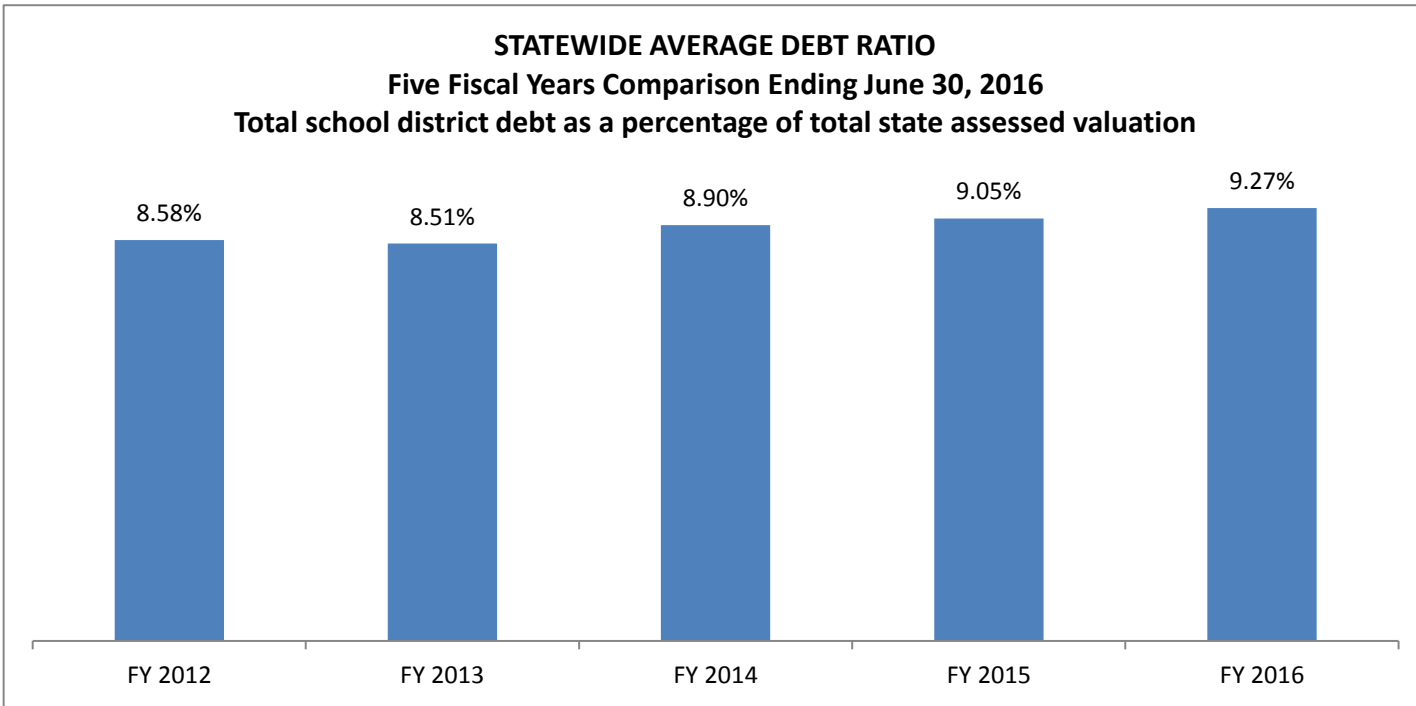

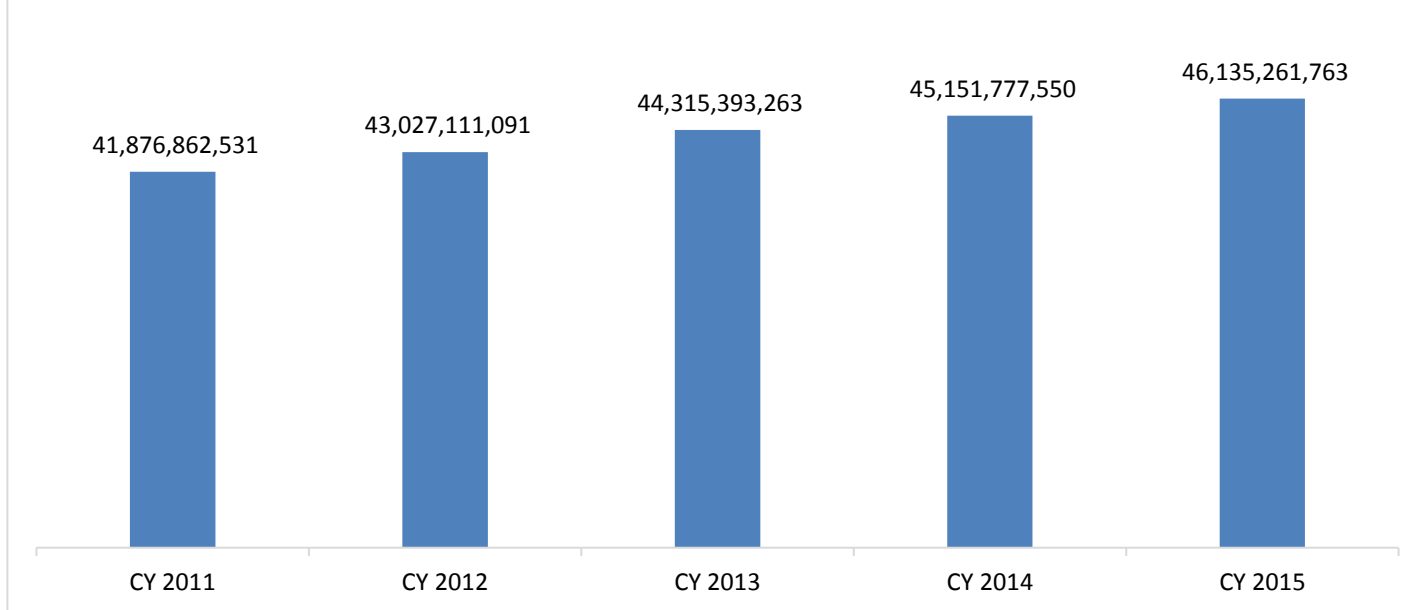

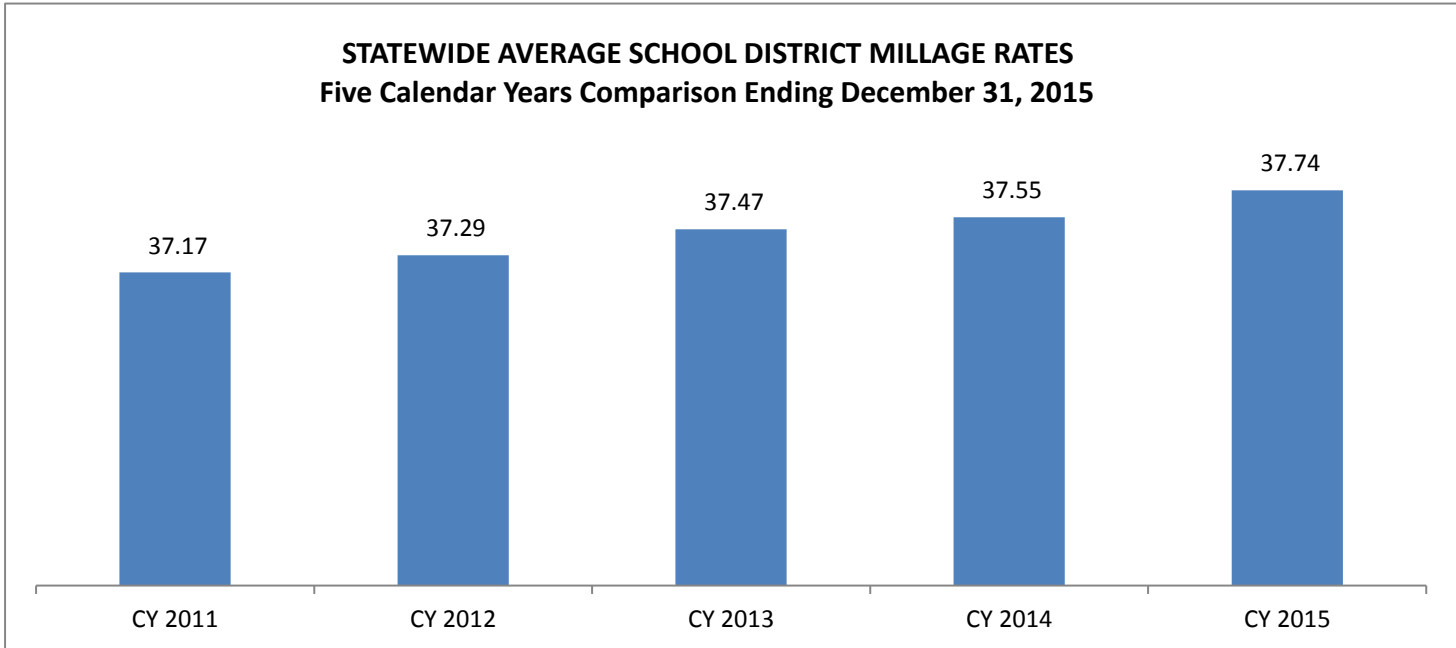

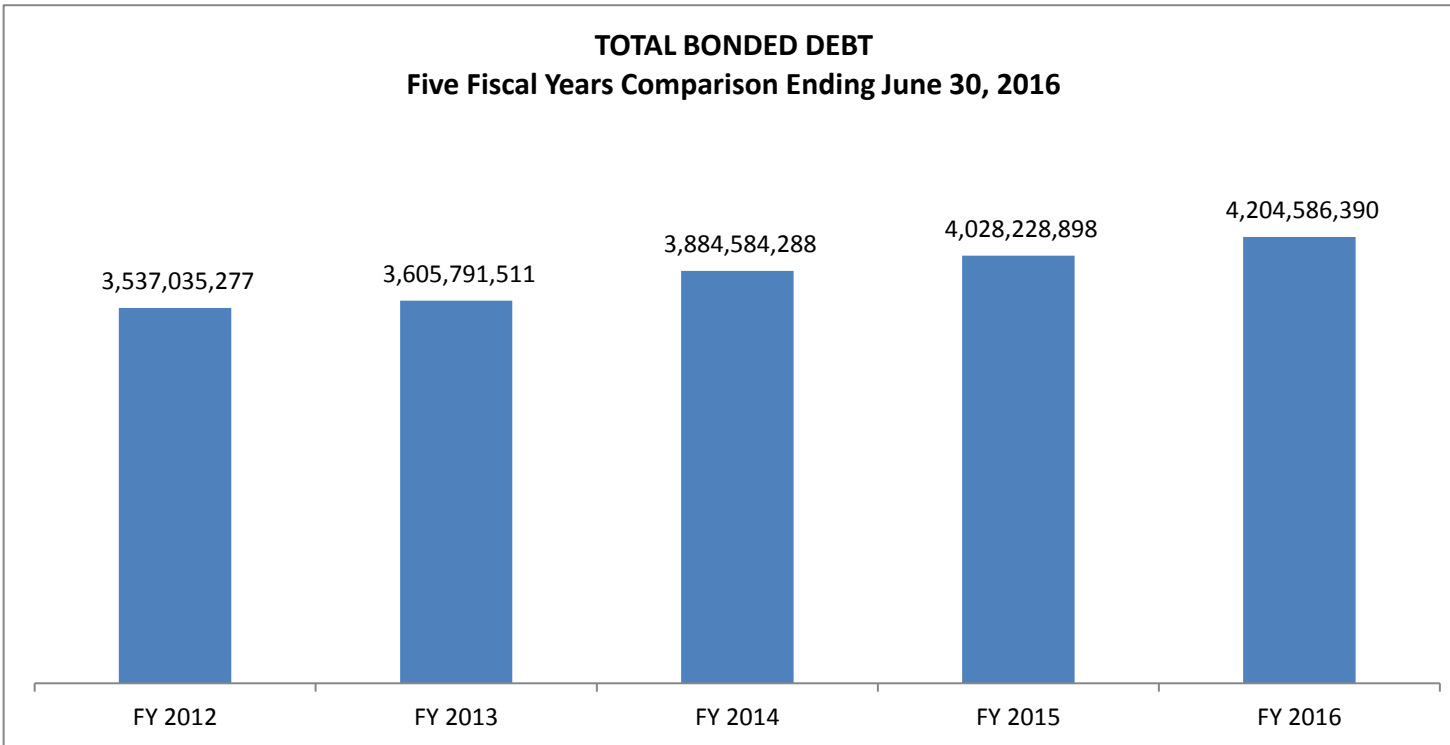

**Five Calendar Years Comparison Ending December 31, 2015**



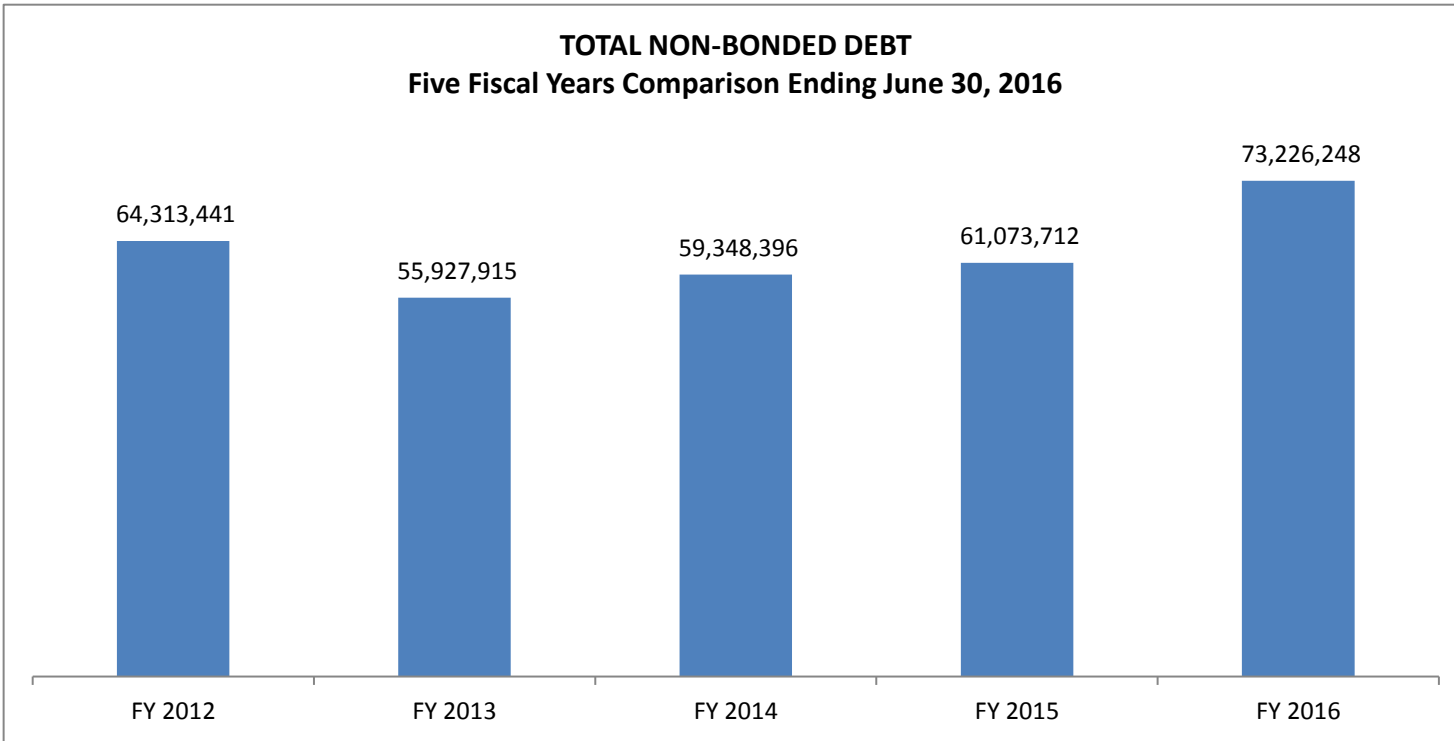

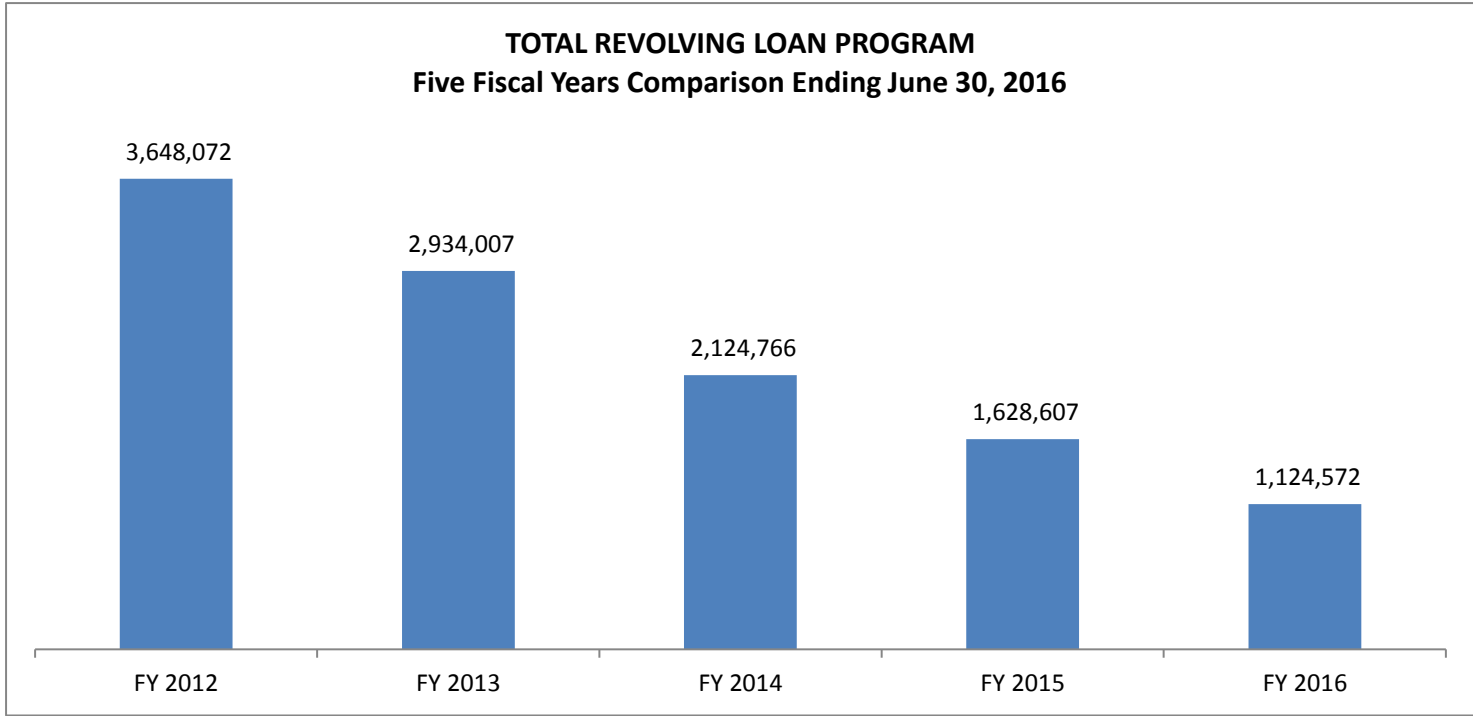
**The average millage rate for school districts increased 0.19 mills (0.50%) from 2014 to 2015**
